ONSLOW OUTREACH

On the 12th and 13th of September, PCLS team members, travelled to Onslow as part of our outreach program.

During our visit, our staff organised a sausage sizzle at the Onslow Community Garden, with the aim of generating interest within the community and promoting our regular visits to Onslow.

Over the span of several hours, numerous community members joined us for sausage sizzle and a conversation. This event served as an opportunity for Onslow residents to gain a better understanding of the services offered by PCLS. Additionally, it provided an excellent platform for our staff to collaborate with other community service agencies.

One notable success during this outreach was our financial counselling team's assistance to a client facing a mortgage shortfall. Through advocacy, our team managed to prevent a bankruptcy lodgement and secured a waiver of \$111,000 on behalf of the client. We also assisted clients with their power bills, offered guidance on superannuation, and shared general financial knowledge.

The following day, our staff set up office within the local shire hall, located in the heart of town on the main street. Once again, during our half-day presence, numerous residents accessed our services, resulting in several new clients benefiting from our assistance.


















Community Migrant Services Session

HOUSING SUPPORT

Our Community Migrant Service Workers provide one-on-one casework, support, information and linkages to other mainstream services to assist migrants.



LEGAL SUPPORT

Our legal team offer free legal advice and assistance in the areas of family law, restraining orders, child protection matters, and criminal injuries compensation.



REDRESS SUPPORT

Our Redress Support Workers are here to help survivors of sexual abuse understand the Scheme, talk about feelings and guide them through the application process.



DOMESTIC VIOLENCE SUPPORT

The role of our Domestic Violence Support Workers is to provide support to victims of family and domestic violence through safety and crisis intervention planning, informal counselling, support planning, advocacy, court support, assistance with Violence Restraining Order applications and education.
